



**Abstract of the call for selection of students for participation to the Double degree programme: AGH University of Science and Technology, Kracow (Poland) and Master Degree in “Consulenza e Gestione di Impresa (curriculum International Management)”, Università degli studi di Messina Academic Year 2020-2021**

The Department of Economics of the University of Messina (from now on UniME) selects n.2 students enrolled in the first year (a.y. 2020/21) of the Master Degree Course in “Consulenza e Gestione di Impresa (curriculum International Management)”, to participate in the **Double Degree programme in International Management** with the AGH University of Science and Technology of Krakow (from now on AGH) (Poland).

UniME subscribed an agreement with AGH for the establishment of a structured mobility pathway for obtaining a Double Degree within the Master Degree Program in Consulenza e Gestione d’Impresa (International Management curriculum) at UniME and the Master Degree in International Management at AGH.

Students selected within this call will opt for a double degree programme based on the following study programme:

### Successful students will get a Double Master Degree issued by UniME and AGH.

Selected students from UniME will attend the first year at their home University (UniME) and the second year at the AGH as established in the above scheme. The partner universities mutually recognize the credits acquired by the student for the provision of the double degree in International Management. A tax waiver policy will be adopted, according to the provisions of the specific agreement stipulated between UniME and AGH (available at the link: <https://www.unime.it/it/dipartimenti/economia/evidenza/double-degree-international-management>).

### Eligibility

In order to participate to this call, students must be enrolled in the first year of the Master degree course in Consulenza e Gestione di Impresa (curriculum International Management) for the A.Y. 2020-2021 at UniME.

### Terms and conditions for the submission of the application

The application must be drawn up on plain paper, according to the attached model, duly dated and signed, under penalty of exclusion, accompanied by a valid identity document. The application MUST be submitted in pdf format via email to [protocollo@unime.it](mailto:protocollo@unime.it) and, in carbon copy, to the coordinator of the Degree Course, Prof. Francesco Ciruolo (e-mail: [francesco.ciraolo@unime.it](mailto:francesco.ciraolo@unime.it)), and to [dipartimento.economia@unime.it](mailto:dipartimento.economia@unime.it) indicating in the object field of the e-mail "Domanda per selezione Doppio titolo Messina - Master Degree in International Management", **by and no later than 10 September 2020.**

### Candidates must enclose to the application form the following documents

1. Valid identity document
2. A transcript of records (list of exams taken and relative marks) of the Ist cycle Degree course and final graduation mark;
3. Certification attesting the level of knowledge of the English language;
4. CV in english duly signed;
5. Photograph in electronic format (jpeg format, resolution 236x295 or more, aspect ratio 4: 5; dimensions not more than 1MB) ;
6. A signed declaration by the student, attesting the enrollment or pre-enrollment in the first year of the Master degree course in Consulenza e Gestione di Impresa (curriculum International Management), Università degli studi di Messina.



In the event of a tie, priority will be given to the youngest candidate.

Applications received after the indicated deadline, or produced and/or received in different ways, will be excluded.

UniME reserves the right to ask, selected students, for any further documents if requested by the host Institution.

### **Evaluation Criteria**

The ranking will be based on the final degree mark. In case of a tie, priority will be given to the youngest candidate.

### **Selection Committee and final ranking**

The selection Committee is appointed by the Academic Board of the degree course. The composition of the selection Committee will be published, after the expiry date of the present notice, on the department website at the address <https://www.unime.it/it/dipartimenti/economia/dipartimento/bandi>, with notification value from the University.

The final ranking, based on academic merit, will be published on the department website and on the section amministrazione trasparente of the UniME website (<https://www.unime.it/it/dipartimenti/economia/dipartimento/bandi>).

### **Acceptance and waiver**

The first two candidates usefully positioned in the final ranking will be selected for the double degree programme.

The selected candidates will be required to communicate their acceptance within 7 days from the publication of the selection results to [protocollo@unime.it](mailto:protocollo@unime.it) and to [dipartimento.economia@unime.it](mailto:dipartimento.economia@unime.it) under penalty of forfeiture of the right to participate in the program.

In case of withdrawal, exclusion or forfeiture of a selected candidate, the ranking list will be scrolled down to the following candidate.

The scroll notification will be sent to the suitable candidate, usefully placed in the ranking. Within the peremptory deadline of 3 days from the communication, the candidate must explicitly and unequivocally consent to the scrolling of the ranking in his favour sending an email to [protocollo@unime.it](mailto:protocollo@unime.it) and to [dipartimento.economia@unime.it](mailto:dipartimento.economia@unime.it).

After this period, the candidate will be considered tacitly renouncing.

### **Support to mobility**

The 2 selected students, if not Erasmus + scholarship recipients for a mobility to AGH, will benefit from a financial contribution that UniME attributes to those students who carry out an international mobility for the achievement of a double degree. The amount of the financial support depends on income. The mobility contributions represent only a financial integration intended to cover part of the costs deriving from the stay abroad and are not intended to cover all the expenses that the student will meet during the mobility period.
