1. **RESIDENT TWINNING ADVISER IN THE TWINNING WITH THE TUNISIAN “Instance Nationale des Télécommunications (INT)” TN/13/ENP/TE/27b – CRIS N°346737 – 2016-may 2017**

With the AGCOM resolution n. 64415 CONS, I have been nominated as **Resident Twinning Adviser** in the twinning with the Tunisian institution ‘ *Instance Nationale des Télécommunications –INT-*’ starting from the 14 march 2016. But since november 2015, I have participated as a expert to the twinning with the INT, with the aim of focusing on issues on procedures and penalties commitments, access to administrative documents, public consultation. After explaining the Italian legislation, we have proposed some changes to the tunisian law on telecommunications. Since February 2016, I have been in Tunis for participating to the recruitment of the assistant and the interpreter of the resident twinning adviser. During this period, I have worked on a daily basis with the all parties involved in the twinning to implement the project, to support and to coordinate activities, to ensure the continuity of its implementation. The parties involved in the twinning are the Unité de Gestion du Programme (UGP), the Delegation of the European Union, the AGCOM, the Centro servizi, assistenza, studi e formazione per l’ammodernamento delle P.A. (FORMEZPA), the Instance Nationale des Télécommunications (INT), the Comisión Nacional de los Mercados y la Competencia (CNMC-Spain), et, the Ministère de l’Economie, de l’Industrie et du Numérique (DGClS, France). During my mandate, I have given a particular emphasis on implementation and institutional set up, as well as a good management, communication and language skills. During my mandate, all the delay have been solved, the Steering Committees have been planned and executed, the study tours have been well organized, in Spain, France and Italy, the calendar of activities has been regularly updated, the missions and trainings have been regularly organized, with the mutual satisfaction of the all parties involved, also the issues have been quickly solved as the replacement of the Chief the project of the Beneficiary Country and the replacement of the Heads of the Components of the twinning.

2. Participation as an expert and coordinator in 9 international missions to **NTRA (National Telecommunication Regulatory Authority of Egypt)**, into the twinning project of AGCOM. Infact, my predecessor was a Director. I have signed contracts for millions of euros. I had the responsibility to take care of the relation with the Authorities in charge of the registration of contracts and taxes. I expressed to the Secretary General any proposals to improve the functionality of the Headquarters of Naples, the employee working conditions and the decor of the building. Under the recommendation of the General Secretary, I coordinated the survey on the condominium costs since 2003; I coordinated the officials of the service, I coordinated the verification of thousands of invoices at the end of the survey, I offered to pay an amount much lower than that required. . I have held a dialogue with the Postal Police and the Financial Police ("Guardia di Finanza"). Starting in May 2014 and in accordance with Law No. 114/2014, I conducted the research coordination of a building for the Authority's headquarters in Naples, through site visits and meetings with public and private Institutions. I was the coordinator of a Group for the elimination of administrative documents at the Headquarters in Naples (7 months of work, eliminating 270 boxes, 20 meetings). I created a quick procedure for the resolution of problems in coordination with the head of security concerning thousands of reports (on elevators, windows, bathrooms, electrical conduits; installations of any type; water seepage, power outages, repairs and maintenance, etc.). I created a database with all the reports, with a priority order. For each report, I coordinated the communication with the suppliers; informed the Director of the service and the other Directors; I chose the offers, I participated to the inspections, I came into contact with the Office for the expenses. I performed the role of representative of the General Secretariat at the meetings of "Preconsiglio" with Advisers of Commissioners and Directors of Directions. I proposed the opening of the sanction procedures and I was involved in drafting of injunctions to the Council; reporting to the Legal Department for legal defense; reports, internal notes, requests for information, reminders, tips. I have received and examined all documents of the proceedings. I have participated twice to the activities of the Unit "Par Condicio" during political and administrative electoral campaigns.
