- Noted that the University of Messina promotes the inclusion of migrants, refugees and asylum; seekers through the initiatives of the CEMI Interdepartmental Center "Center for Migration, Social Inclusion and Intercultural Communication ";

- considered that the University of Messina has joined the "Manifesto of Inclusive Universities " promoted by the United Nations High Commissioner for Refugees (UNHCR) with the aim of facilitating access to higher university education and promoting inclusion of beneficiaries of international protection;

- considered that, based on art. 3 of the aforementioned Manifesto, the Universities reserve specific scholarships for students and researchers who are beneficiaries of international protection;

- considered that art. 4 of the manifesto provides for actions for the legal entry of refugee students also in third countries to whom specific scholarship are reserved;

- noted that the University of Messina has joined, with other Italian universities, the National Protocol among the same universities, UNHCR, Ministry of Foreign Affairs of the Italian Republic (MAECI), Italian *Caritas*, Diaconia Valdese, Gandhi Charity and other associations, linked to the University Corridors for Refugees project - UNICORE 3.0 (Ethiopia - 2021/2023) involved in the project;

- considered that the aim of the Project is to promote university corridors for the right to study in favour of refugee students in Ethiopia;

- according to the guidelines of the Project and the agreements shared with all the participating universities, even in relation to the criteria and methods for selecting students referred to in this enrolment call;

- considered that the University of Messina, by deliberation of the Academic Senate prot. n. 15270 of February 3rd, 2021 and deliberation of the Board of Directors prot. n. 15254 of February 3, 2021, gave CEMI a mandate to start all the activities useful for the achievement of the UNICORE Project;

- based on the CEMI deliberation of 9th February 2021 which approved the following Call "University Corridors for Refugees 3.0 (Ethiopia - 2021/2023) " for 2 study grants and welcome services for refugee students enrolled in master's degree courses in English at the University of Messina for the academic year 2021-22

Art. 1 Objectives, subject and terms

The general objective of the **University Corridors for Refugees** - **UNICORE 3.0** (Ethiopia 2021-23) project is to promote the right to higher education of refugees through the creation of educational corridors from Ethiopia to Italy. The Project is promoted by a consortium of partners:

United Nations High Commissioner for Refugees (UNHCR)

Caritas Italiana

Diaconia Valdese

Italian Ministry of Foreign Affairs and International Cooperation (MAECI)

The Italian Universities better specified in the Cooperation Agreement

The University's commitment has been formally sanctioned with the adhesion to the Cooperation Agreement for the realization of the UNICORE 3.0 project.

The beneficiaries of the Project are holders of international protection residing in Ethiopia and admitted to one of the master's degree courses listed in article 9.

The benefits will be awarded for the 2021/2022 and 2022/2023 academic years. The merit requirements for the maintenance and renewal of the study grant are specified in article 6.

1.1 Local partners

The University of Messina, on the basis of the commitments formalized with a specific local Cooperation Agreement n. 72/2021, Prot n. 28096 del 01/03/2021, is supported in the Project by the following local partners: Arcidiocesi of Messina Lipari S. Lucia del Mela (hereinafter called Arcidiocesi), Diaconia Valdese, AXUM, Community of Sant'Egidio, Circolo ARCI Thomas Sankara (hereinafter referred to as ARCI).

1.2 Benefits and supports offered

Benefits included in the scholarship to all the winners will be the following:

- full coverage of the expenses to be faced before the arrival in Italy: flight tickets, Visa and preparation of supporting documents (Arcidiocesi);

- free Italian course 40 hours before departure for selected students who request it (University for Foreigners of Siena);

 $- \in 3,000$ annual scholarship for the two-year master's degree. Payment will be divided in installments and subject to the achievement of merit requirements. Winners will be provided with more information upon enrollment (University of Messina);

- exemption from academic fees (University of Messina);

- accommodation in a university residence starting from October (University of Messina);
- free meals at university canteens on opening days (University of Messina);
- enrollment in National Health System (Diaconia Valdese);
- Italian SIM card and subscription (Arcidiocesi);
- public transportation subscription (University of Messina);

- psychological support through services provided by the CERIP University Center (University of Messina);



- free Italian language course (University of Messina);

- integration kit of \in 8.00 daily for the purchase of books, one laptop, stationery, mobile phone recharge, medicines, clothing (Arcidiocesi);

- pocket money for 24 months (\notin 2.00 daily granted by Arcidiocesi + \notin 60.00 monthly granted by Diaconia Valdese);

- university tutor to support integration into university life and in solving problems related to study (University of Messina);

- legal support (Arcidiocesi, ARCI).

Art. 2 Incompatibility

The UNICORE 3.0 study grant is incompatible with:

- any type of merit based study grant/prizes promoted by the University of Messina in favour of international students;

- study grants issued by the Ministry of Foreign Affairs and International Cooperation (MAECI);

- CRUI grants for beneficiaries of international protection;

- study grants issued for international students and promoted by foreign governments or institutions on the basis of agreements with the University of Messina;

- regional scholarship for the right to study offered by Sicily region (ERSU).

Art. 3 Requirements for admission

Application is open exclusively to candidates who meet the following requirements:

- 1. are residing in Ethiopia and have been recognized the refugee status in collaboration with UNHCR.
- 2. Hold a qualification valid for admission to the chosen Second Cycle Degree Programme, namely: a. issued by a higher education institution accredited by the Ministry of Education of the country

that issued the degree;

- b. valid for access to an on-site second cycle level degree Course;
- c. obtained after 2016.

3. Have achieved a grade point average (GPA) of at least 3.0, calculated on the basis of the Ethiopian higher education grading system, or equivalent.

4. Meet the specific admission requirements of the Second cycle degree program of interest.

5. Have never been enrolled before in a degree programs at the University of Messina or at any other partner university of UNI.CO.RE.

Each student can apply to a maximum of two universities participating in the project, indicating the order of preference in the application.

Art. 4 Selection criteria and documents required for the application

4.1 Selection criteria

Students are selected on the basis of merit requirements.

The evaluation will be carried out by a commission of experts appointed by a specific Rector's decree.



4.2 Application documents

Students are required to submit the following documentation: MANDATORY DOCUMENTS

1. the application form attached to this call (see Attachment 1);

2. a copy of their currently valid Refugee Identity card issued in collaboration with UNHCR;

3. a certificate confirming the qualification required for admission to the chosen degree programme;

4. transcripts of exams passed and relative marks;

5. GPA documentation;

6. any relevant and additional document required for the admission to the chosen degree course.

NOT MANDATORY DOCUMENTS

1. Motivational letter (maximum two A4 pages);

2. references from a supervisor or advisor;

3. candidates are warmly recommended to shoot a short video CV (e.g. using their mobile phone) in order to introduce themselves and explain their motivations (examples of such videos can be found on the Internet).

All documents, mandatory and not mandatory, must be in English or Italian. In this phase the translations can be done directly by the candidate.

4.3 Deadlines and modalities

Applications can be sent from March 1st at $12:00 \pmod{-\text{UTC}+1}$ to April 1st, 2021, at $12:00 \pmod{-\text{UTC}+1}$.

Students are required to send their application, including all the documents listed above, to the e-mail address <u>protocollo@unime.it</u>, specifying in the subject field "UNI.CO.RE. project ".

The manager of the administrative procedure is Dr. Marcella D'Arrigo.

Any requests for information can be sent to <u>darrigom@unime.it</u> and <u>cemi@unime.it</u>. Incomplete or incorrectly completed applications will not be taken into consideration.

Art. 5 Selection process

The selection process is divided into two steps:

1. evaluation of the documentation;

2. online interview.

5.1 Step 1: evaluation of the documentation

The committee of Experts will evaluate the documentation received according the following criteria:

- Academic background and GPA (score: 0-15);

- evaluation of CV (score: 0-15);



- coherence between previous studies and selected Second Cycle Degree programme (score: 0-10).
At the end of the first qualification session, a ranking will be drawn up and only the first 15 candidates will be able to access the interview step. With the same score, the younger candidate precedes.
Candidates admitted to the second step will be notified by e-mail by 10 May 2021; the partial ranking will also be published on the website www.unime.it on the same page where this announcement is published.

5.2 Step 2: online interview

All candidates admitted to step 2 will be interviewed by the Committee of Expert. Interviews will be performed in English. During the interview the technical-academic skills, as well as the level of knowledge of English required by the degree course, will be evaluated.

Interviews will take place starting from May 17th and will be held on line.

The date and time of the interview will be notified by e-mail directly to the candidates, as well as published on the website <u>www.unime.it</u> on the same page where this announcement has been published.

During the interview, candidates will be asked to show the Refugee *Identity Card or the PoR Card* indicated during the admission step. A third party is supposed to be present at the beginning of the interview to confirm the student's identity.

The maximum score assigned for the interview is 40 points.

5.3 Establishment and approval of the final ranking list

Candidates who at the end of the two steps will have obtained a score lower than 50/80 will not be considered suitable.

The merit ranking will be drawn up by the commission by adding up the partial results obtained in the two selection steps.

Candidates will be listed in decreasing order of score.

The ranking will be approved by Rectoral Decree.

In order to guarantee equal access opportunities, two separate rankings will be drawn up based on the gender of the candidates. The two study grants will be awarded to the candidate with the first result of each ranking. In the absence of candidates in one of the two rankings, the scholarship will be awarded to two candidates of the other ranking.

With the same score, the younger candidate precedes.

The winners will be notified by e-mail by 5 June 2021 and the final ranking will be published on the website <u>www.unime.it</u> on the same page where this announcement has been published.

5.4 Acceptance

In order to confirm the scholarship candidates must reply to the University's e-mail communication within ten days of receiving the selection result. Failing to provide a feedback by the given deadline will cause the loss of the benefits.



By accepting the scholarship, the candidate fully approves the benefits offered by the UNICORE 3.0 project under the conditions indicated in this call for applications. With the acceptance students also confirm under their own full responsibility that they do not fall within any of the conditions of incompatibility established in article 2 of this call for applications.

5.5 Scrolling of rankings and assignment of available seats

In case a candidate winner of the scholarship officially withdraws, the University will proceed with the scrolling of the ranking by assigning the scholarship to the next suitable candidate.

If at the end of the scrolling of the ranking there are vacancies, the University of Messina reserves the right to search for an eligible candidate in the rankings of the partner universities of the project. Eligible candidates identified must meet specific requirements requested by the Degree Courses of the University of Messina.

Art. 6 Renewal

6.1 Requirements for renewal

In order to renew the scholarship for the second academic year, students are required to earn at least 24 University Credits (CFU) by 31 July 2022.

Students must graduate by October 2023.

6.2 Additional renewals

Students who do not succeed to graduate by October 2023 will be able to apply for an additional 6-month renewal. Renewal can be granted on condition that at least 100 university credits (CFU) have been acquired by 31 July 2023. The renewal request must be submitted by e-mail to protocollo@unime.it by 31 July 2023.

Art. 7 Withdrawal from the course

Students who withdraw from the program during their studies will automatically lose all benefits of the scholarship.

Art. 8 Information notice concerning data processing
