## Migration side event

in the occasion of G7 Summit Italy, Sicily 26-27 May 2017

**Ortygia Business School**, in collaboration with the **University of Messina** and the **Alliance of Leading Universities on Migration (ALUM)**<sup>1</sup>, proposes to hold a side-event on the margins of the Taormina Summit on 26-27 May, 2017 to upgrade the Migration Compact Non-Paper with a coordinated, evidence-based set of proposals leveraging universities' unique educational capacity, independent research and public policy expertise.

### Ortygia Business School

Ortygia Business School is a new institution offering business education in the form of executive courses and high-level meetings between managers, academics, and policymakers.

Our guest lecturers and speakers include academics from among the best universities in the world, senior business people, and policymakers with extensive market and policy experience.

Our location reflects the school's mission: to build management capabilities that will foster economic development and growth in the countries of the Mediterranean. However, our courses and events are also of interest to a broader audience.

The School provides the skills and knowledge necessary for future business leaders to succeed in turbulent institutional conditions, while offering a global perspective, a broad understanding of the world economy, and best practices from international businesses.

### ALUM

ALUM is a unique collaboration among key universities in Europe and frontier countries in North Africa and the Middle East, forging an alliance to help bridge the gap between research and policy in the management of the current migrant and refugee crisis. ALUM is a commitment from the highest level within the participating institutions aimed at identifying the key units and researchers ready and willing to contribute their expertise to work across national and disciplinary boundaries towards evidence-based policy solutions. ALUM is willing to reason publicly, to interact directly with private stakeholders and governmental institutions and, if need be, to engage in closed door negotiations for maximum impact. ALUM now has twelve European institutions as members and has recently been joined in its efforts by the American University of Beirut (AUB). In all its events ALUM has engaged deeply with policymakers from both frontier and destination countries, including Germany, Italy, Spain and Sweden, as well as UN agencies and European institutions.

### The Proposal

Our proposal builds on the Migration Compact Non-Paper put forward by the Italian Government in April 2016 aimed at contributing to an EU strategy for external action on migration. It is meant to support the more recent efforts by UN member states in the New York Declaration and the Global Compacts on Refugees and Migrants adopted by the General Assembly. We aim to work with policymakers and representatives of the private sector and civil society to develop concrete policy proposals and specific interventions based on cutting-edge research and practice, build in experimental features, exploit state-of-the-art tools to measure and ultimately enhance the impact from these initiatives. Importantly, we want to encourage innovative use of existing data and the generation of new high-quality, high-frequency data exploiting social media and smart phone technology, partnering with both public and private stakeholders.

We want to exploit the potential of our institutions to understand the capacities of migrants and the needs of society – and how best to bridge the two in different settings. We believe that universities are uniquely equipped to do so. This initiative draws on the respective capacities for systematic learning across research communities while engaging with the local contexts of origin and transit countries. We believe in intense peer-to-peer interaction between research institutions in frontier countries with impressive records of integration initiatives and institutions in recipient countries with a stronger academic environment, but with more recent and limited experience of responding to massive migration flows.

### The Format

The format of the initiative consists in a conference, that will take place on April 26<sup>th</sup>, 27<sup>th</sup> 2017 at Ortygia Business School, Syracuse.

The event will last one day and a half, from Wednesday 26 at 9:00 to Thursday 27 at 15:00.

The programme will bring together academics, policymakers and NGOs and it will draw on a wide range of disciplines, from economics and international relations to sociology and anthropology.
