Hereinafter collectively referred to as "parties".

This MEMORANDUM OF UNDERSTANDING is designed to foster a friendly relationship through mutual research cooperation.

Both parties have reached agreement on the following areas of cooperation, subject to mutual consent, the availability of sufficient funding and the compliance with migration laws:

- Joint research activities
- Participation in seminars and academic meetings
- Exchange of academic materials and other information
- Other forms of the cooperation presenting mutual interest

The purpose, schedule and numbers of the mobility, terms and duration of the stay as well as other provisions and funding for any specific program and activity shall be mutually discussed and agreed upon in writing by both parties prior to the initiation of a particular program and agreed in the addendum to this MoU. The researcher will exclusively work at the receiving institution only in non-economic activities.

Each institution may designate an individual to coordinate this program and all endeavors that may derive from it.

University of South Bohemia in Ceske Budejovice, Faculty of Fisheries and Protection of Waters (FFPW) designates:

Assoc. Prof. Dipl.-Ing. Vladimír Žlábek, PhD., Vice-dean for foreign relations from the FFPW

and

Universita Degli Studi Di Messina, Department: Chemical, Biological, Pharmaceutical and Environmental Science designates:

Prof. Caterina Faggio.

The University of Messina will not assume any financial responsibilities or funding commitment by this Memorandum of Understanding.

The parties to this agreement by the signatures below of their authorized representatives, acknowledge having read and understood the agreement and agree to be bound by its terms and conditions.

This Agreement comes into force after signature by both parties and shall be in effect from 1.6.2018 to 31.5.2019, at which time it shall be reviewed for possible extension. Either party may terminate the agreement by written notification signed by the appropriate official of the institution initiating the notice. However, such notification must be received by the other party at least six months prior to the effective date of termination.

The states of the parties do not bear responsibility for improper execution of the obligations taken by the parties in conformity with the agreement.

The agreement has been written in the English language, this version is in legal force.


