Article 6 – INSURANCE COVER

Article 8 – THESIS DEFENCE COMMITTEE

The only Examination Board shall be comprised of six members (professors in the same scientific area) including the two thesis advisors that don't evaluate the candidate.

According to the new Italian rules, before the final examination, the thesis will be evaluated by two reviewers that are professors that don't participate in the final evaluation.

The two institutions, by means of the Deans, exchange any piece of information and all documents relevant to the organization of the joint sponsorship described in the present agreement.

Article 9 – DOCTORAL THESIS DEFENCE (PUBLIC DISCUSSION)

The public defence of the doctoral thesis shall take place in Sfax following the deadline provided by the partners law.

The partners agree that the deadline for the final examination is until May 2022 according to the Italian law that doesn't provide an extention of the legal duration of the doctoral course but provides the postponement of the final discussion if the Italian external evaluators of the thesis ask for it.

The two institutions have to consider that the student has to publish a scientific publication to be admitted at the final examination according to the Tunisian regulation. The student will have to submit her scientific publication in due time to allow the final examination until May 2022.

Article 10 - LANGUAGE

The doctoral thesis shall be written in English

An abstract of the doctoral thesis shall be supplied in English.

Article 11 - INTELLECTUAL PROPERTY RIGHTS

Intellectual property ownership will be based on the principle of inventor owns in accordance with the respective policies of each of the partner institutions.
