Dear Prof. Francesco UBERTINI,

In the framework of the EMJD fellowships selection for the academic year 2017/2018, we are pleased to inform you that the Agency adopted its official selection decision. You will find in annex the names of Partner country and Programme country doctoral candidates selected on your main and reserve lists.

As a result, we invite you to officially inform the candidates accordingly and in particular to provide those on the main list with a **formal Erasmus+: Erasmus Mundus (EM) fellowship award letter**. We advise you to give them a deadline of maximum 2 weeks to confirm the acceptance of the fellowship. In case of cancellations, this will allow you to inform the fellowship candidates in the reserve list in due time. In such circumstances, we kindly remind you to introduce a request in the online mobility tool immediately.

The formal fellowship **award letter** sent to the EMJD candidates by the coordinating institutions or the first hosting institution must clearly indicate the following:

- starting date<sup>3</sup> and duration of the EMJD Programme;
- information on the type of fellowships (employment contract conditions)
- information on the social security provided by the consortium;
- information on costs covered by the fellowship, as well as any additional costs that will have to be covered by the candidate (if any);
- information about the visa and residence permit requirements (if applicable);
- information about the mobility path (at least the first hosting institution);
- information on how to open a bank account;
- information about the housing and family facilities;
- Consortium's contact information;
- a reference to the Erasmus Mundus Students and Alumni Association (EMA).

The doctoral candidates on the reserve list must be clearly informed about the conditions under which one can receive the EMJD fellowship. It is strongly recommended to avoid indicating the exact

ranking number of candidates and rather providing more general information regarding their position on the reserve list.

You are kindly requested to assist the non-EU/EEA doctoral candidates as much as possible in obtaining their visa and residence permits when necessary. For this purpose you will find attached the certificate on the award of the Erasmus+: Erasmus Mundus Joint Doctorate Fellowship, containing information about your consortium and on the fellowship amounts. In addition we recommend providing your doctoral candidates with a support letter from each hosting institution, if the mobility path is already known.

In order to facilitate the process of obtaining visa and residence permit the Agency will notify all concerned Delegations of the European Union in the world. The Delegations will be asked to liaise with EU consulates and embassies where necessary. The selection results will be also provided to the Erasmus+ National Agencies, present in the Programme countries, and the National Erasmus+ Offices.

Finally, we ask you for the 2017 SGAs to fully comply with the rules on **employment contracts** as foreseen in the EM Programme Guide and to offer standard employment contracts to doctoral fellows after securing a work visa. As mentioned in the letter of 21/09/2015 (Ares: 3892713, Chapter 3), we would like to remind you that there are risks and liabilities linked to non-compliance with the rules by the coordinating University and/or any of their partner Universities. In particular, non-compliance with the conditions set for the employment of doctoral candidates will have a negative impact on the overall implementation results of the joint doctoral programme as it might lead to:

- Unequal treatment of the doctoral candidates as far as career perspectives and pension rights are concerned;
- Inadequate social security provisions (in case of serious illnesses, accidents leading to invalidity, etc.);
- Inconsistencies and inequality between the contractual conditions for an individual doctoral candidate who has mobility periods in different EU countries;
- Complications with the application process for work entry visa and subsequent issues linked to the registration of doctoral fellows as staff/employees at a university.

It is the responsibility of the coordinating university to ensure that the employment conditions offered in the consortium 'partner' Universities are fully in line with the Erasmus Mundus requirements and mirror the employment conditions offered by the coordinating University itself. EMJD coordinating institutions have also the legal responsibility in case of complaints and/or legal actions by individual doctoral candidates concerning employment conditions and/or contractual obligations that are not being fully met at the coordinating University or their partner Universities.
