The phenomenon of migration is today the most important issue in the world's agenda. Especially in recent years, millions of people have been displaced due to the civil war in Syria and there has been a massive mass migration. In the first place people who were forcibly evacuated because of the war displaced from their homes to neigbouring countries such as Lebanon, Jordan, Egypt and Turkey. Of these countries, Turkey ranks first in without doubt as most refugee hosting countries. Sanliurfa is the city that hosts the most refugees are in Turkey after Istanbul. In the intervening years and the possibility of the continuation of the conflict in Syria and in refugee statuses in Turkey refugees are no longer thinking of going back. Therefore, the process of being integrated into the society should start and empowered as soon as possible. one of the the best ways of the social inclusion in general is to be employed or to be an entrepreneur.

Only a small portion of up to 7% of the refugees living in Turkey are living in the Temporary Accommodation Centers (Refugee Camps). In time, these centers will be closed as the policy of the Directorate General of Migration Management (Turkey). It is because of the living conditions of these centers for many year. It is not suitable for the honour of humans. Not only in Turkey but in general one of the world's most important problems is the problem of social inclusion of the migrants especially refugees who are forced to be displaced from their homelands. Therefore, in this project, we aim to contribute to the problem of social inclusion by producing a solution proposal through social entrepreneurship of young refugees who are young with fewer opportunities . We want to work with young people especially when reaching this goal. Young people, if they have a job, facilitate their social inclusion, thus contributing to social integration by creating an exemplary role for their community as stronger and empowered individuals.

Since the Erasmus+ aims at promoting equity and inclusion by facilitating the access to participants with fewer opportunities and disadvantaged backgrounds compared to their peers. Also the transnational strategic partnerships aim to develop initiatives addressing the field of youth and promote innovation, exchange and know-how between different types of organizations involved in youth. So that, we believe that designing skill developing programs that young man and woman refugees' skills and matching them with the needs of the market will improve refugees' quality of life, empower their inclusion in the society and contribute to the economy which makes it easy to be included in the society.

## **Project Description**

Please explain the context and the objectives of your project as well as the needs and target groups to be addressed. Why should this project be carried out transnationally?

Turkey has the highest population of the refugees (forced migration) in the world. Because of the Syrian Internal Conflict, millions of people have been displaced from their hometowns. After the city of Istanbul, the city of Sanliurfa hosts the highest number of refugees which is about 600.000 people. There are many effects of the Syrian Crisis in Turkey, such as:

Population, Demography, Socio-Cultural Change

The Structure of the city and municipality services

Local working market and local economy

Social Entrepreneurship

Social Inclusion Problems.

Adoption of the work permit regulation for temporary protection status holders in 2016 is an indicate of a shift towards long-term planning concerning the Syrian refugees in Turkey. Yet, many remain informally employed in poor and very bad conditions.

Especially refugees are dealing with many difficulties and disadvantages most importantly, educational difficulties, economic obstacles and cultural differences. In order to reduce these obstacles and disadvantages. In the project we will try to make one of the aims of the Erasmus+, social inclusion, through social entrepreneurship. Because we believe social entrepreneurship covers the economy, education and culture.

For all these effects and reasons Turkey and the world need a long term and sustainable solutions for the humanitarian service. Unless the migration movement is handled well the ultimate result is often exclusion of individual migrants and their communities. According to the resources there are more than 100.000 young people in the city of Sanliurfa are unemployed. The majority of these people are refugees from Syria. So, we would like to carry out this project transnationally with the organizations from Turkey, Greece and Italy to have a strategic partnership and expert organizations to cope with this problem and exchange of good practices and exchanging the experiments of the partners. In sum, youth with fewer opportunities, in this project are refugees who are belonging to a national or ethnic minority, with linguistic adaptation and cultural difficulties.

What results are expected during the project and on its completion?

The main result of the project (during and after the project) is to create opportunities for employment for the youth with fewer opportunities (young refugees between the age of 25-30). These young refugees will have a training for social entrepreneurship. After the training they will have mentors according to their interest areas. The project will also help to the local and international organizations to work on this issue and improve and build their capacities stronger. This project will end with creating working opportunities and sustainable social inclusion process for the local community and refugees who has limited access for the opportunity because of many reasons. Another sustainable result of the project is to create a mentor pool for the entrepreneur candidates. There will be 25 mentor candidates will be training to meet the refugees. After the training they will be in the mentorship tool.



In what way is the project innovative and/or complementary to other projects already carried out by the participating organisations?

Previously similar projects were carried out by Sanliurfa Teknokent (Science Park) for the strengthening of the companies, particularly through mentoring in Turkey. Our project will be a project to strengthen youth with fewer opportunities and mentors for individual mentees. In this respect, we are introducing an innovative project.

How did you choose the project partners and what will they bring to the project? Does it involve organisations that have never previously been involved in a Strategic Partnerships project?

The project partners have been chosen according to their working and interest areas. Below, our partners and their interests were briefly written. Thus, we think that our project will be successful when they come together. All of the partners in the project have been involved in many strategic partnership projects with international partners. But for Erasmus+ Some of our partners has involved in Strategic Partnerships projects before. But the coordinator of this project and partners from Turkey has never previously been involved in a Erasmus+ Strategic Partnership project. Thus, they will have a very new experience for them. The partners which are new in the field will have the opportunity to expreince of Erasmus + facilities for social inclusion. Thus, a very important social responsibility will be fulfilled.

The project participants are chosen a combination of working areas as well as their legal status. Therefore in the project we have universities, NGOs, government institutions, and social entrepreneurs. All together coming under the umbrella of this project to create a strategic partnership.



How will the tasks and responsibilities be distributed among the partners?

1- ŞANLIURFA TEKNOKENT (SCIENCEPARK): The location, building, and the management staff of the coordinating organization Teknokent is quite suitable for this project. Teknokent will take the full responsibility of the project. The companies that are on the board of directors are: Harran University, Şanlıurfa Governorship Investment Monitoring and Coordination Department, Şanlıurfa Commodity Exchange, Şanlıurfa Chamber of Commerce and Industry and Şanlıurfa Metropolitan Municipality. Therefore, this project will be carried out by Şanlıurfa Teknokent. In other words, the coordination of our project will be undertaken by Teknokent on behalf of all these institutions. So, in general Sanliurfa Teknokent will share the responsibility of the management of the project and some of the intellectual output of the project. Şanlıurfa Teknokent will also responsible of the -the organization of the project launch event

2- Directorate General of Migration Management (Turkey): The Directorate General for Migration Management has been established under the Ministry of Interior with a view to implement policies and strategies related to migration; ensure coordination between the related agencies and organizations in these matters; carry out the tasks and procedures related to foreigners' entry into, stay in, exit and removal from Turkey, international protection, temporary protection and protection of victims of human trafficking. This partner will be consultant and helpful for the formalities of the project. It will also help us monitoring and the publication of the outputs of the project to a wider audience.

3- BERANET SOFTWARE: BERA YAZILIM, a Social Enterprise company, will be working on all software, social media, and online web portal, etc. projects of our project. Bera Yazılım will also be responsible of the preparation of online web portal and newsletter of the project

4- Ege Sistem Bilisim Hizmetleri Sanayi ve Ticaret Limited Sirketi, will be responsible from the trainings of the refugees and curriculum development working with our partner from Greece.

5- NSTITUTE OF ENTREPRENEURSHIP DEVELOPMENT, working together with Ege Sistem to build the curriculum and share the experience of the trainings of the social inslusion and entrepreneurship.

6- HARRAN UNIVERSITESI GOC POLITIKALARI UYGULAMA VE ARASTIRMALARI MERKEZI: The center, which conducts academic studies on immigrants and migrants especially in Şanlıurfa, will support the reporting of academic and especially intellectual outputs of our project. HÜGÖÇ will also be responsible of the preparation of project booklet and the management of the design, edition and publication of project booklet, framework guide and training materials.

7- HORİZON DERNEĞİ: Horizon is a non-governmental, non-profit humanitarian organization working in accordance with international standards of humanitarian privacy, seeks Through its educational, developmental and social activities to develop the lives of vulnerable people who are affected by conflicts, humanitarian crises and subjected to human rights violations. The partner will help in the project especially in the ares to reach young refugees. Horizon has a wide refugee network in the city of Sanliurfa.

The members of the board of directors of Şanlıurfa Teknokent are Harran University, Sanliurfa Governorship Investment Monitoring and Coordination Department, Sanliurfa Commodity Exchange, Sanliurfa Chamber of Commerce and Industry and Sanliurfa Metropolitan Municipality, as well as various large companies are under the management of Teknokent. Dissemination and exploitation of the results of our project are very important areas of the Erasmus+ project lifecycle. Thus, these institutions and organizations will provide their support to an activity that will be done by Teknokent. ### Participants

Please briefly describe how you will select and involve participants in the different activities of your project?

Participants will be involved directly:

via social entrepreneurship training: 40 young refugees between the age of 25-30 These 40 young man and woman will be selected by an online application form on the website of the project. Before the application there will be invitation annoucements for application to be a candidate of social entrepreneurs. These young people are supposed to be refugees between the age of 25-30. We selected this age to make the training easy in the classroom and to empower the young people. Candidates will be selected as 20 male and 20 female candidates.

#### via mentorship training: 20 mentor candidates

Mentor candidates will apply online as a mentor candidate. They will be selected according to their CV, and theris working experience. These mentor candidates should have experience on managing and organization. They will be trained to be mentors to support the young people with fewer opportunities.

Participants will be involved indirectly from open access online web portal and social media account. Also there will be intellectual outputs and brochures and newsletters. These all will help the project to be known and indirectly involving people.

How will you support these participants so that they will fully engage in the planned activities?

There are no participants with fewer opportunities among the participants who will participate in the management meetings and represent the participating organizations. However, since our project will give trainings to the refugee youth, especially 40 entrepreneur candidates, these refugee youth is with fewer opportunities in various aspects. Various opportunities will be provided at Teknokent to participate in training and mentor-mentee interviews. In addition, road and food support will be provided to the participating young people who have difficulty in participating in the trainings.

Please describe briefly how and in which activities these persons will be involved.

40 Refugee youth (20 man - 20 woman) with fewer opportunities will join in the training courses on Social Entrepreneurship for a certain time. At the same time 20 mentor candidate will take mentorship training. These training will be given at the conference halls of Teknokent and also there will be online courses given by our partner organizations. After the trainings of both sides, there will be mentor mentee matching. These mentors will support mentees to start new social enterprises.



#### Preparation

Please describe what will be done in preparation by your organisation/group and by your partners/group before the actual project activities take place, e.g. administrative arrangements, communication about the activities, selection of the persons, coaches, involvement of stakeholders, etc.

After getting approval for our project, first of all the coordinator of the project, Dr. Hakan Gülerce, will send an e-mail to the partners of the project. For this there will an e-mail list to be used for the communication. In this e-mail all partners will be invited to have an online meeting through Skype or Appear.in. In this meeting we will discuss about the kick-off meeting of the project which will happen in Sanliurfa. Particularly date and content of the kick-off meeting should be decided all together with the partners. All partners will be asked to provide one person for communication. This person will be asked to be available and make sure to respond all the emails on time. Another very important issue is all e-mails will go to all partners in order to make the knowledge and information accessible for all.

Before starting the activities of the project, Coordinator will make sure to organize a kick-off meeting in Sanliurfa at the first week of the project. In this meeting all partners will come together and work on the root and the way of the project to implement it in the best quality way. In the kick-off meeting all the partners with coordinator institution will sign and Interior Partnership Agreement. All responsibilities will be shared in a written format and signatures of the representatives of the organization will be collected under the responsibilities. We will focus on the ways and means of the communication between the partners in deep and make everything clear in this meeting. This is vital for the projects quality. The communication channels should always be open for a successful project. Before starting the project activities we will make sure of this issue.

Also, before project activities, we will make sure who are the representatives of the partner organizations. These people should be qualified for the project. These representatives will be selected according to their skills of communication, experience in the projects and managing/organization.

Another issue is to inform the University management about the project and to get their approval to use necessary places and facilities of the university during the project. This will also help us to get necessary approvals for any travel for the project in the future.

We will also ask our National Agency in Ankara for their comment and suggestions for a successful project. If there are any trainings and conferences on this we will definetly attend to improve our project management skills. We will also inform our partners to inform their institutions to make news on their websites and social media. This will also help us to disseminate the project's aims and will help us to keep the motivation high.

Our project coordinator Dr. Hakan Gülerce has experience on the budget control and time management of the project. He has a master degree on Managing and Organization Department in Marmara University. He worked for some well known companies as project budget manager. We have a clear timeline for the meetings. All of these meetings will be participated according to the responsibility of the partners. Sanliurfa Teknokent staff is also very experienced in the project budget management. Dr. Hakan Gülerce will work in collaboration with the financial department staff of the Sanliurfa Teknokent.



How will the progress, quality and achievement of project activities be monitored? Please describe the qualitative and quantitative indicators you will use. Please give information about the involved staff, as well as the timing and frequency of the monitoring activities.

Our project is expected to produce increased quality in the preparation, implementation, management and all other sections of the project. To have a good and hight quality outcomes from the project the progress should be managed in a high quality way.

There will be a special team to monitor the progress, quality and achievement of the project activities. The team members who have experience in monitoring and managing projects will be selected for this very important work. One member from each partner will be selected to monitor the progress, quality and achievement of the project. These representatives for control will meet online or if we are having transnational meetings, they will meet specially and discuss about the progress, quality and achievement of the project.

Every three months we will have surveys for testing the quality and progress of the project. Also during the trainings, mentors and social entrepreneur candidates will fill the survey forms.

Also the monitoring team will make first test and last test to see the change and progress in the project.

After and before every project meeting, the monitoring team will work and make a report to develop a road map and discuss it in the project meeting.

Additionally, In the trainings we will also use and benefit from the SALTO Resource Centers to help improve the quality and impact of the project. The module also will be shown to Harran University and Messina University related departments to check the quality.

Lastly, at the beginning, at the kick-off meeting to have a quality framework will be agreed on by all the partners to ensure a high level quality for the project, including signing the "quality agreement".

How will you evaluate to which extent the project reached its results and objectives? What indicators will you use to measure the quality of the project's results?

To evaluate to which extend our project reached its result, we planned to monitor in two steps during the project schedule.

Step 1: Project Timeline Control List (First 15 months of the project)

During the transnational meetings all the steps and timeline of the project will be checked again and get the approval of the partners. Especially for the first step is the developing curriculum for the social entrepreneurship and the trainings of the young refugee people and mentors.

Step 2: Project Performance and Impact Feedback (Last 9 months of the project) During a transnational meeting there will be a special feedback session for mentor mentee matching and partners will se how the quality of the project's results. These will be shown with the success stories and number of the new social enterprises which came out of this project.

All project staff is experienced and expert of their fields not only the coordinator of the project but partners also. That is one of the important key factor which increases the quality of project. Also their network is really important for dissemination activities. Another importance about the staff of Sanliurfa Teknokent, all of them are close corporates which some of them already have collaborated in the past.



What are your plans for handling risks which could happen during the project (e.g. delays, budget, conflicts, etc.)?

a- In the condition of conflict between partners: One of the most important problems is conflict between partners in transnational projects. Especially the approaches of partners and being negotiable during controversial issues are so important. Generally this kind of situations can be considered as administrative inability and unequal management. We think the best way of preventing conflicts between partners is meetings, making the connection strong and problem solving if there are problems face to face. Because of that we are giving importance for kick-off meeting. Kick-off meeting is also a conversancy event for partners. So the protocol will be signed at the kick-off meeting which is very important to prevent conflicts.

b- Withdrawal of a partner from the project: These kinds of situations generally occur if there are unexpected cases. The mandate helps to minimize and regularize the partnership relations. In this condition National Agency of Turkey will immediately informed and will be asked for advise.
c- Delaying in working plan of the project: Sanliurfa Teknokent is responsible as the coordinator for pursuing project plan management. If the problems are causing because of the partners, in that case partner means that partner is no obeying the project work plan and partnership mandate. On that case Sanliurfa Teknokent should inform the EU project management department to solve this kind of problems. In this condition Turkish National Agency will also be informed and their advice will be considered.



#### Implementation

Please explain how will the project activities lead to the achievement of the project objectives and delivery of the planned results?

The aim of the project is to empower the refugee youth with fewer opportunities thorough social entrepreneurship. For this aim the objectives of the project are:

- To develop a training module and curriculum on social entrepreneurship for refugee youth.

- To develop a training module and curriculum on social entrepreneurship mentorship for refugee youth for mentor candidates.

- To train a pilot group of social entrepreneur candidate refugee young people and social entrepreneur mentor candidates.

- To start a center for mentroship pool as a sustainable output of the project for future use.

- To develop a online web portal for the refugee social entrepreneur candidates and mentor candidates.

- To share the success stories for motivation and encouragement of young people.

- To create awareness of the rights and possibilities for the refugee youth in the business area. So to achieve all of these objectives we need to do the activities of the project, such as transnational meetings, intellectual outputs, mentorship and trainings.

How will you communicate and cooperate with your partners?

We will communicate with the partners through e-mail and skype. Also the representatives of the project will have a special social media group for immediate and faster communication. But all the rules and regulation and responsibilities will be written and signed. But the communication will be done by using institutional email and all partners will be informed by Carbon Copy in the e-mail. The formal communication method is decided as e-mail. For the cooperation we have already signed mandate, after approval our project at the first meeting we will have another protocol between the partners where the responsibilities of the partners are clearly mentioned.

#### Impact

What is the expected impact on the participants, participating organisations, target groups and other relevant stakeholders?

First of all the most important impact will be on our target group young social entrepreneur candidates and the mentors. The social entrepreneur candidates will have trainings and tools for their empowerment and for their future dreams to come true. Also the mentors will have trainings and they will use their experience and knowledge to mentor the social entrepreneur candidates. The role of mentors will be encourage the young people with fewer opportunities. Also the special website will be built by one of our partners will be open access and many other organizations will be able to benefit from them. The content of the website will also include the success stories of the social entrepreneurs, so that will be inspiration for the other people with fewer opportunities. It will also create awareness among the visitors of the website will be one of the most essential impacts of the project. This project also will help to develop the experience and capacity of the Sanliurfa Sciencepark (Şanlıurfa Teknokent).

- Sanliurfa Sciencepark as the coordinator will serve and coordinate the project. This will help to develop to be a bridge between university and industry. This is the first aim of the Sanliurfa Sciencepark establishment. So the project will help to serve for the aim of the Sciencepark. It will also help to create a very important awareness of the capacity of the Sciencepark and develop the managing capacity of the it. Also there will be sustainable mentorship pool as a part of Sciencepark. So that many young people with fewer opportunities can benefit from it.

-HÜGÖÇ, Directorate of Migration of Turkey and MESSINA University of Italy, jointly work on intelectual part of the project and this will add a great value and impact on the intelectuals working here. Since they are experienced of the migrant studies, they will jointly publish both a report and scientific work. - HORIZON is the non government organization, which works for the refugees for their employments and needs. The project will have a great impact on the organization to help and reach out the refugees as their main work.

- Egesys from Turkey and Institute of Entrepreneurship Development from Greece will add experience to their companies / organizations more experience to deal with the training of the refugee youth in English, Turkish and Arabic language. So in the future projects these open access trainings may be used.

- As more indirect effect, project will effect the economy of the Turkey and will help social inclusion and integration of the refugees through social entrepreneurship.



What is the desired impact of the project at the local, regional, national, European and/or international levels?

Since Turkey and European countries having the refugee crisis, and the problem of the socio economic integration of the migrant refugee youth this project will create a very important impact the local, regional, national and European levels. With the three language website it will also indirectly effect the all people in the world to use the tools according to their needs. The project will help youth with fewer opportunities to develop their skills and strengthen their encouragements for social entrepreneurship through coaching and mentoring. This will help the social inclusion at the local and regional level.
