SICILY SUMMER SCHOOL FOR GREEK AND LATIN CLASSICAL HERITAGE Messina, 27 June – 15 July 2016

Deadline for Registration: 20.05.2016

Article 1 (General Information)

For the Academic Year 2015-2016 the University of Messina will be running the 'Sicily Summer School for Greek and Latin Classical Heritage' (27 June - 15 July 2016), lasting three weeks, in the English language, awarding:

- 5 CFU/ETCS (University Learning Credits/European Credit Transfer System) (Greek or Latin course)
- 9 CFU/ETCS (University Learning Credits/European Credit Transfer System) (Greek and Latin course)

The programme is run by the DICAM (Dipartimento di Civiltà antiche e moderne, viale Annunziata - Polo Universitario, 98168 Messina: http://www.unime.it/dipartimenti/dicam/).

Learning outcomes:

- 1. Language knowledge (Greek elementary/advanced and/or Latin elementary/advanced level: h 60, frontal lessons). See online http://www.unime.it/dipartimenti/dicam/.
- 2. Study of classical heritage through an intensive programme in Literature, History of Religion, Greek and Roman Art History, Archaeology, Numismatics (h 30, frontal lessons, conferences, workshops, and archaeological tours).

Attendance is compulsory. The minimum percentage of attendance is 70%.

Certification of the successful completion of the programme and the issue of 5 (Greek or Latin courses) or 9 (Greek and Latin courses) CFU/ETCS is subject to:

- i. payment of all fee instalments within the established deadline;
- ii. achievement of a minimum attendance of 70%;
- iii. a pass in the final examination (at least 18 out of 30).

The programme will run with a minimum of 10 or a maximum of 20 enrolled students.

Applications will be accepted until all places are filled. The programme will not start if the minimum number is not reached.

As soon as the minimum number is reached, applicants will be contacted by the organizers of the Summer School.

In the case of non-activation the University will request an IBAN code linked to the personal bank account of the enrolled person to reimburse the fees paid.

Article 2 (Admission requirements)

The programme is reserved for candidates who, at the time of registration, are 18 years or over and are in possession of a secondary school diploma.

Italian auditors are allowed to participate for free in the programme (please contact: adistefano@unime.it). They are not allowed the same duties and rights as the paying participants.

Article 3 (Registration and Delivery of the documents)

Candidates must fill in the Application form, sign it and send a scanned copy to the following address: adistefano@unime.it (no later than 20.05.2016) together with:

i. a copy of a valid identity document

ii. a copy of a certified secondary school diploma

iii. a scanned passport size photo

iv. a copy of the payment of all installment fees (bank account: IT 16 W 02008 16511 000300029177 [please indicate: 'sottoconto n. 15'])

Applications submitted with incomplete documentation and after the deadline will not be accepted.

Article 4 (Other information concerning registration and delivery of documents)

The University of Messina will not be liable for lost or misdirected communications due to incorrect addresses given by candidates or the late or non-notification of changes to the address, or any other difficulties which are caused by third parties, acts of providence or force majeure.

In the event of any false declarations made in the documentation presented by the candidates, relevant for the purposes of registration, without prejudice to the penalties laid down in art. 76 of Presidential Decree no. 445 of 28th December 2000, such candidates will not be permitted to register and will not have any right to reimbursement of the fees paid. Any false declarations will be subject to claims for damages by the affected parties.

Article 5 (Tuition fees)

Students participating in the programme are required to pay the following tuition fees:

- 950 EUR (one course: Greek or Latin) to be paid in a single installment at the time of registration;
- 1300 EUR (two courses: Greek and Latin) to be paid in a single installment at the time of registration.

The programme is not subject to exemption from registration fees for tuition (as per DPCM 9 April 2001, art. 8, para. 1).

Article 6 (Fee payment by third parties)

The cost of the student's enrolment to the programme may be supported by third parties (public authorities, foundations, businesses, etc.).

Payment of fees by third parties must be formally recorded (in a letter of commitment or contract) by the date set for registration: otherwise alternative methods of payment will not be accepted.

Following payment, the University may issue an accounts receipt excluding VAT pursuant to articles 1 and 4 of Italian Presidential Decree no. 633/1972 and amendments.

Article 7 (Accommodation and facility access)

Free student residence rooms (Residence Annunziata, University campus) are available to international students. The Summer School participants may use the Campus dining hall, open for lunch and dinner (meal price: EUR 7,00), and the swimming-pool (CUS Annunziata) (free of charge).

Article 8 (Withdrawal from the programme)

Any candidates wishing to withdraw from registration must immediately notify (dgionta@unime.it), attaching a copy of their ID, in order to allow the places to be given to other applicants. Reimbursements will be made **only** if the course is cancelled or if they are unable to obtain a visa.
