Medical University “ Prof.Dr. Paraskev Stoyanov”- Varna, Bulgaria (here after referred to as Varna Medical University) and University of Messina, enter into this cooperation agreement to establish a program of exchange and collaboration in areas of interest and benefit to both institutions:

I.

The goals of the cooperation between Medical University Varna and the University of Messina are as follows:

- To promote interest in the teaching and research activities of the respective universities;

and

- To deepen the understanding of the economic, cultural and social issues environment of the respective universities;

II.

To achieve the above goals, Medical University Varna and University of Messina will allow to:

- Promote institutional exchanges by inviting faculty or staff members of the partner University to participate in a variety of teaching and/or research activities and professional development;
- Send and receive undergraduate, postgraduate and PhD students of the partner University for periods of study and/or research agreed in advance;
- Organize summer schools and vacation practices for undergraduate, postgraduate and PhD students;
- Participate in the development and implementation of joint research projects within various programs;



- Organize scientific symposia, conferences and meetings on research issues;
- Participate in academic and administrative staff exchange;
- Exchange of scientific publications, literature and library information;
- it can get to involve and collaborate with other Institutions, Foundations, Universities and various Institutions in Europe and beyond.

III.

To achieve the above goals, is expected to take part in European tenders and others public and private agencies, to obtain, the whole or partly, the required funding to the common activities.

IV.

Each institution shall designate a coordinator to oversee and facilitate the implementation of this contract with the following responsibilities:

- To promote academic collaboration at both universities, student levels for research and study;
- To act as a principal contact person for individual and group activities and to coordinate the activities within their universities as the partner university;
- To distribute to each university information about the university, staff, facilities, research publications, library materials and educational resources of the other university;

V.

The specific program of the academic cooperation shall be agreed on for each academic year and shall be included in an Annex which is to be considered an inseparable part of this Agreement.

VI.

The contract is signed in two identical copies in English language, each one of equal binding force. It comes into effect at the moment of its signing and it is valid for a period of 3 years. In the case of termination the parties agree to give a 6-months' written notice to the other party. Otherwise the contract is renewable by mutual consent.



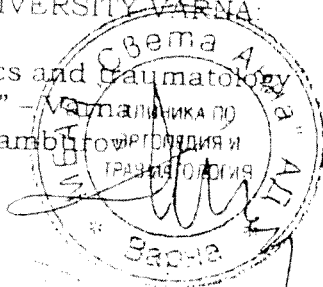
